## Art. 2 / SELECTION

Participants in the mRf25 Advanced Masterclasses are classified as either active students or auditors. The teachers may conduct a selection process to determine the number of active students for their course. Those who are not included in the list of active students will have the opportunity to attend the course as auditors. For the Clarinet, Accordion, Transverse Flute, and Orchestra Conducting courses, a video audition is required. Below are the steps to follow to apply as an active student:

1.

Upload the video for your video-audition at the following link: <https://www.musicariva.org/altoperfezionamento>

For the Clarinet, Accordion, and Transverse Flute courses: the video must contain a performance of the student lasting between 2 and 10 minutes. The repertoire is freely chosen, as the only purpose of the video is for the teacher to understand the student's general level of preparation.

For the Orchestra Conducting course:

Video characteristics:

- length: 10 minutes
- the student must conduct an orchestra
- the student must conduct at least two different pieces or two different movements
- free repertoire

**For all courses: the video must be uploaded no later than 12:00 a.m. (midnight) on June 1st, 2025.**

## Art. 2 / SELECTION

The organizational secretariat of the courses will send an email to each student communicating in which list they have been placed by the teacher, whether among the active or auditor students. The email will be sent by June 11th, 2025.

3.

Only after knowing in which list the student has been placed (active student list or auditor student list) it is possible to fill out the registration form at the following link: [www.musicariva.org/altoperfezionamento](http://www.musicariva.org/altoperfezionamento), including payment of the attendance fee. There are different fees if you register as an active student or as an auditor student.

**This registration must be completed no later than 12:00 AM (midnight) on June 15th, 2025.**

If all steps have been completed successfully, the student will be officially enrolled in the desired course.



## Art. 2 / SELECTION

For the Advanced Masterclasses in Violin "The resolution of technical and stylistic problems of the violin repertoire through instrumental physiology", the Misa Tango course, and the Bass Clarinet course, a video audition is not required.

To enroll in these courses, visit the website page <https://www.musicariva.org/altoperfezionamento> and fill out all fields of the registration form with the required information. The students' registration will be considered complete and valid only after the course participation fee has been paid.

**You must complete your registration no later than 12:00 AM (midnight) on July 1st, 2025.**
