

INFORMATION FOR THE PROCESSING OF PERSONAL DATA PURSUANT TO ART.13 EUROPEAN REGULATION NO. 679/2016 - SUPPLIERS -

1. DATA CONTROLLER

The data controller is the Associazione Musica Riva, with headquarters in Palazzo San Francesco, viale della Liberazione 7, 38066 Riva del Garda (TN).

2. DATA PROCESSED

On the occasion of the relationship with the Supplier, personal and invoicing data, bank, telephone and e-mail addresses are acquired and processed.

3. PURPOSE AND LEGAL BASIS OF TREATMENT:

The data are processed for the fulfillment of legal (administrative, fiscal, accounting, etc.) and contractual obligations and fulfillments to which the interested party is a party. The legal basis of their treatment is represented by the need to fulfill the contractual relationship and / or legal obligations related thereto.

4. TIMES OF CONSERVATION OF DATA

The data will be kept for the time necessary for the execution / management of the relationship with the Supplier in accordance with the provisions of current regulations (10 years).

5. NATURE OF CONFERMENT

The conferment of data is free but the refusal to provide certain data may make it impossible to perform the services related to the relationship.

6. MODALITIES OF TREATMENT

The data are processed in compliance with the technical and organizational security measures provided by the EU Regulation through appropriate procedures to ensure the confidentiality of the same. The data will not be processed through automated decision-making processes. All data provided are treated according to the principles of fairness, lawfulness and transparency in both paper and electronic form and protected by technical and organizational measures to ensure appropriate levels of security under Articles. 25 and 32 of the GDPR.

7. SCOPE OF DATA DISSEMINATION

The data may be known by the owner, the person in charge of the treatment, by the persons in charge of the treatment specifically instructed. In addition to the subjects just specified, the data provided may be processed by third parties, appointed as data processors to the extent that this is necessary for the performance of activities carried out by them in favor of the owner and within the limits of the authorization profiles identified for them. The data communicated will not be transferred to third countries or international organizations outside the EU.

8. RIGHTS OF THE INTERESTED PARTY

At any time the interested party may exercise the rights under Articles 15 et seq. of the European Regulation No. 679/2016 and specifically: the right to know whether their personal data are being processed and therefore to know the content and origin, to verify its accuracy or request its integration, cancellation, restriction, updating, rectification, transformation into anonymous form or blocking, as well as the right to oppose in any case, for legitimate reasons, their treatment and to complain to the Guarantor for the Protection of Personal Data.
